Arenas: Showing in heated *Indoor Arena* with excellent sand footing. Two indoor sand warm up arenas. Intro classes may to be ridden in small arena.

Awards: Each class awarded six ribbons. Show Champion & Reserve Champion awarded to all divisions. Championship Series Awards will be presented following the April 17th Show. To be eligible for Series Championship Awards, horse & rider combination must show in 3 out of the 4 shows. Awards based on accumulated points: 1st = 6 points, 2nd = 5 points, 3rd = 4 points, 4th = 3 points, 5th = 2 points, 6th = 1 point.

Classes: Current USDF/USEF tests will be used. Shows will be conducted under USEF rules unless otherwise noted by show management. ASTM approved helmets must be worn by all Jr. riders at all times. Sr. riders are strongly suggested to wear ASTM approved helmets. Management has the right to combine or divide classes as needed. Classes will be divided between Jr. & Sr. divisions if entries warrant.

Coggins: Negative Coggins required for all horses within 12 months. Coggins must be presented before horses can be unloaded. Name on Coggins must match name of horse on entry form.

Confirmation & Ride Times: Competitors will receive confirmations & ride times by email. Visit www.showsecretary.com to confirm you are listed for the classes which you planned to enter. Contact show secretary if your entry does not appear or if the classes listed are incorrect. *Tentative* ride times will be posted to the website but may change up until the day of the show. Check Day Sheet for *confirmed* times.

Dogs: All dogs must be leashed at all times.

Entries: Entries with Coggins and payment should be mailed to the Show Secretary with checks payable to CDT. Complete entries will be accepted in the order received. Failure to submit a complete entry form may result in you being placed on the wait list. Entries must be post-marked on and including the closing date or until the show is full, whichever comes first. Show committee reserves the right to limit entries, limit the classes per horse, to add, divide or cancel classes or make whatever changes required by circumstances of the competition. Each entry must be signed by the rider, owner of horse, trainer and parent if applicable.

Fees: Make checks payable to Cincinnati Dressage Tradition (CDT) or credit card authorization.
